What is SAP Process Control?

SAP Process Control is typically used by business and technology teams in large and medium sized organisations to help businesses protect themselves against internal fraud. The goal is to strengthen controls where most needed, and eliminate any that are redundant or low-value.

The information PC provides is up-to-date because the status of your controls is monitored continuously, directly from your business applications (SAP or non-SAP) and in an automated fashion. The information you see is reliable and current, allowing you to make business decisions with confidence.

PC has the capability to detect failures or issues, enabling a user to act quickly to mitigate these problems and reduce the company's risk position. The automation of controls within the solution significantly reduces the workload on demanding tasks such as testing, and provides assurance, as it is based on systematic checks of all business data, not just on samples.

The key benefits of SAP PC include:

- The ability to automate control tasks.
- Improve efficiency by identifying, prioritising, and focusing resources on key business processes and risks.
- Gain real-time visibility into compliance and internal control processes.
- Detect issues earlier, proactively analyse control failures, and monitor remediation.
- Comply with a range of regulations, for example, anti-bribery and corruption, data protection, financial compliance, IT controls and industry requirements.


